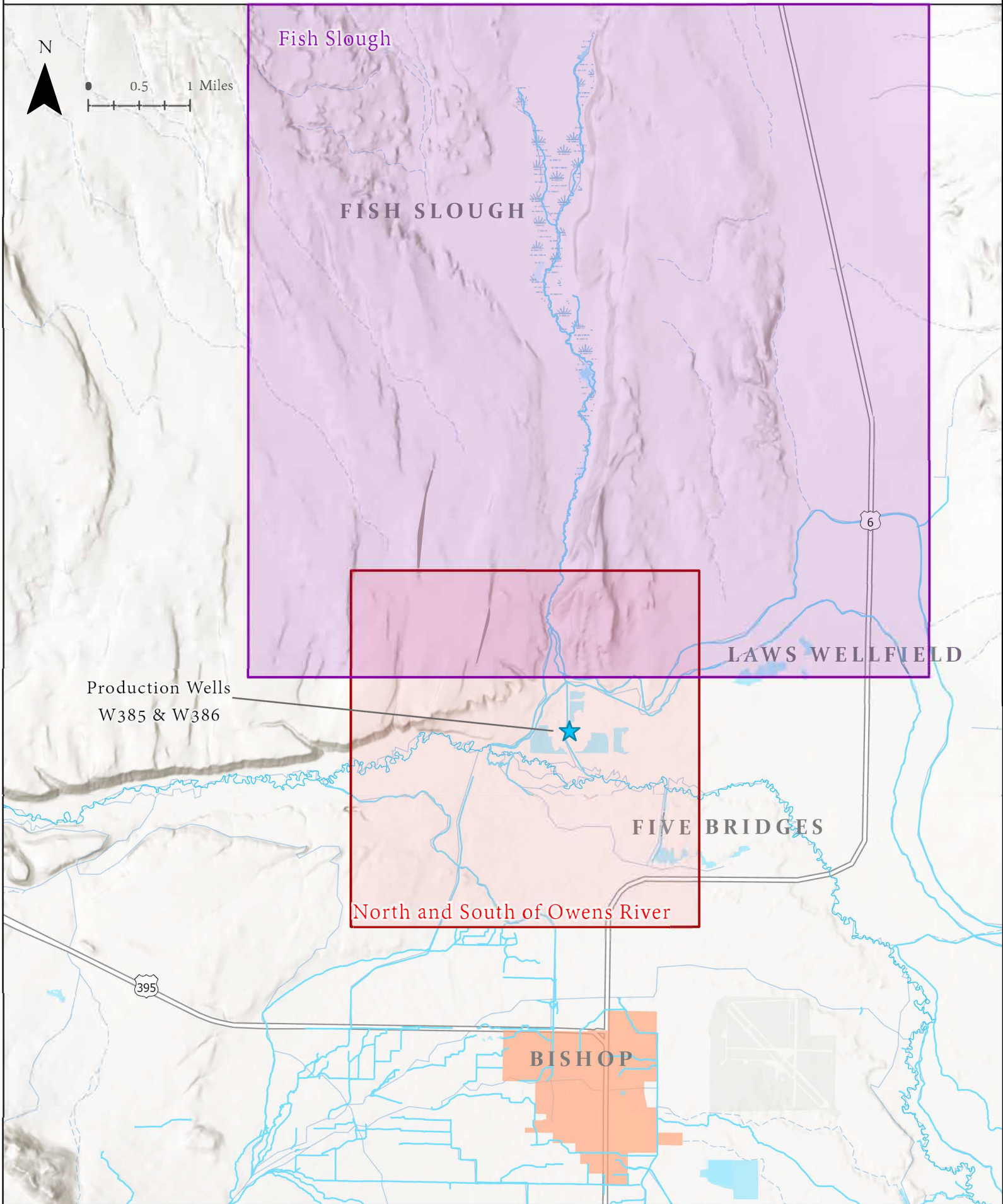

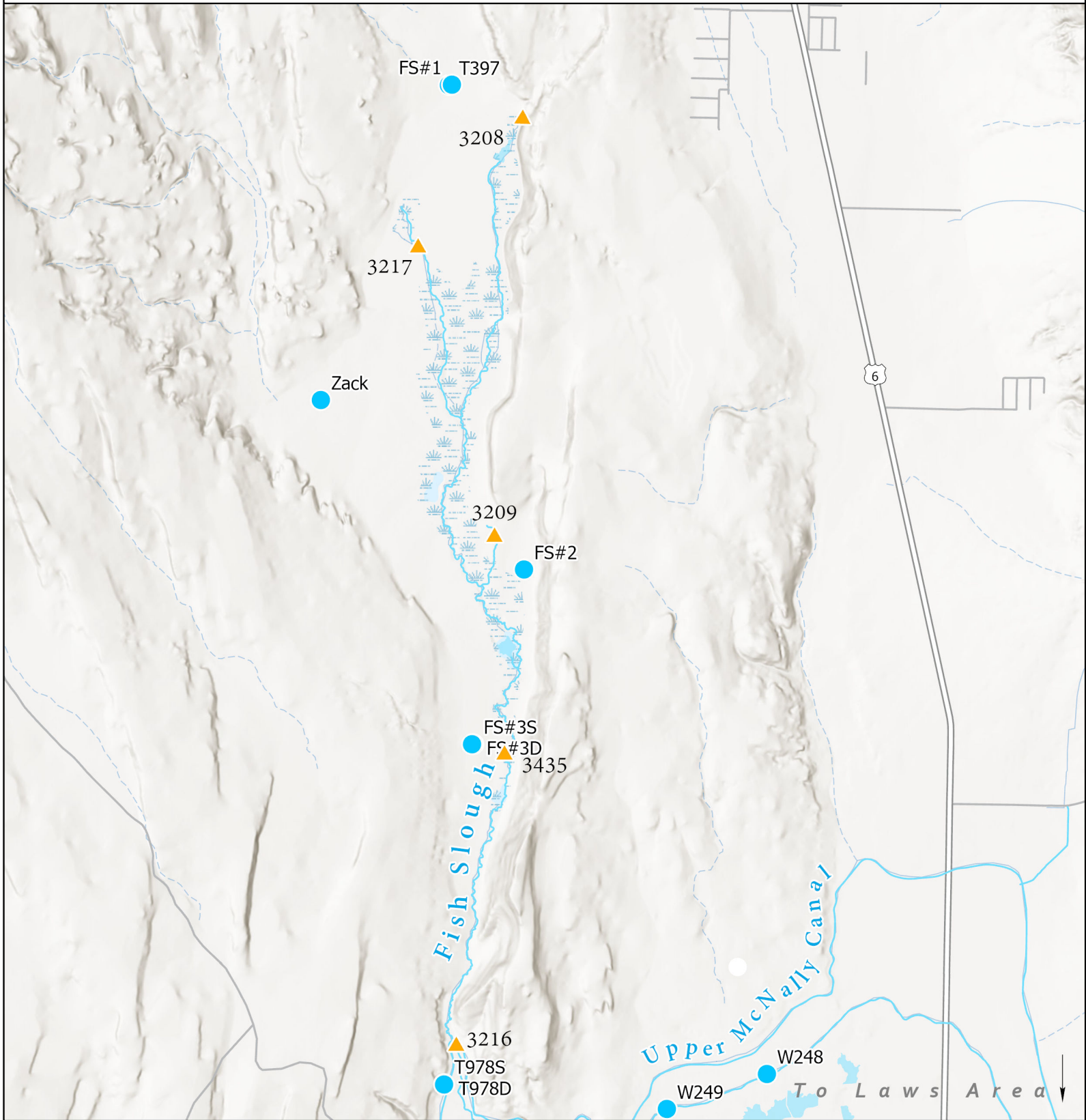

W385 - Fish Slough Area

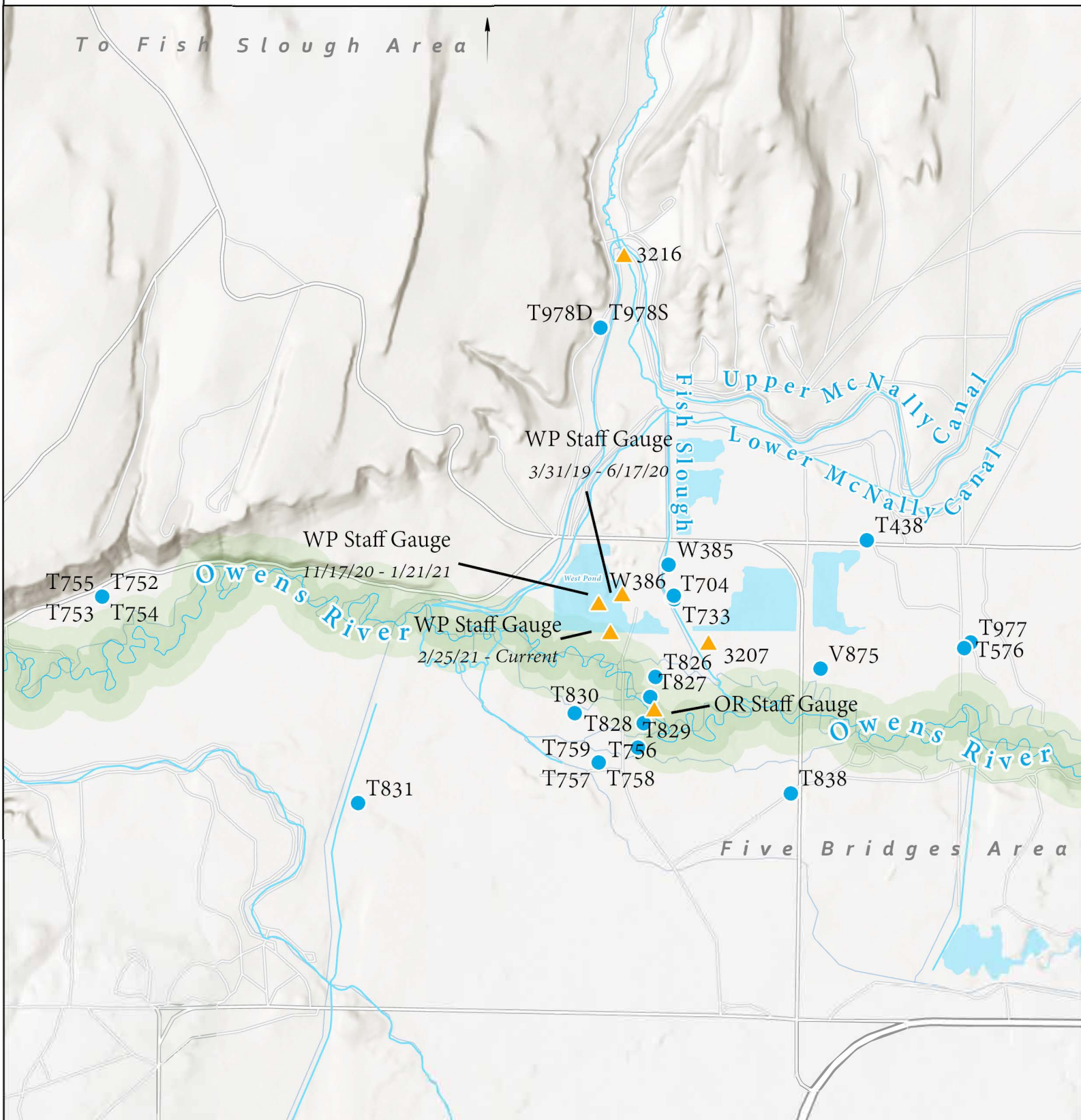

North and South of Owens River



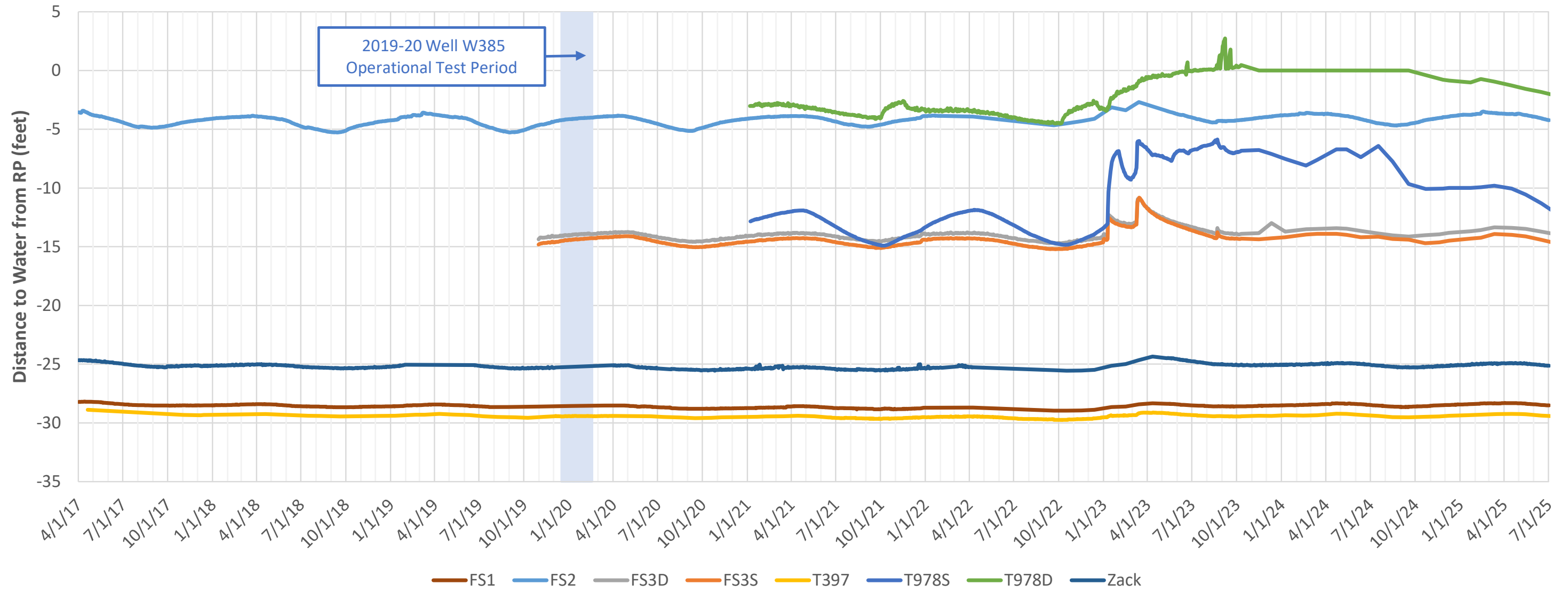

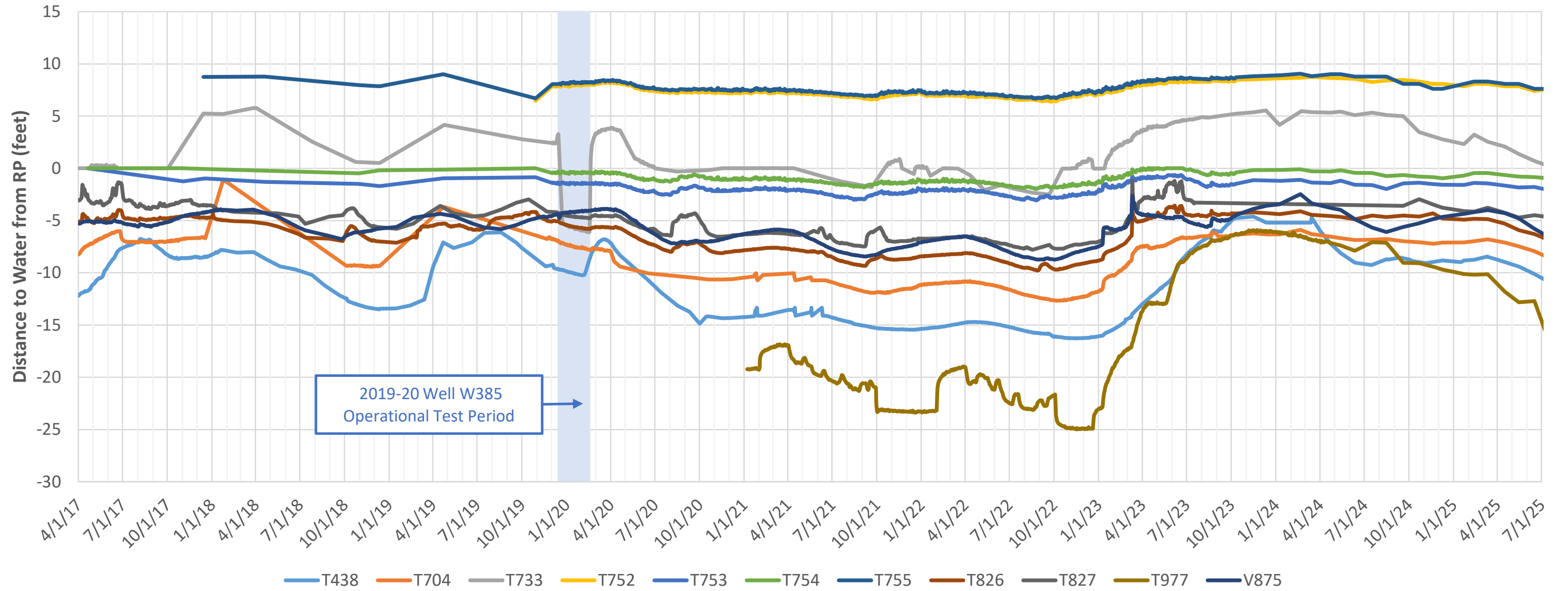

Test Monitoring Wells - Fish Slough

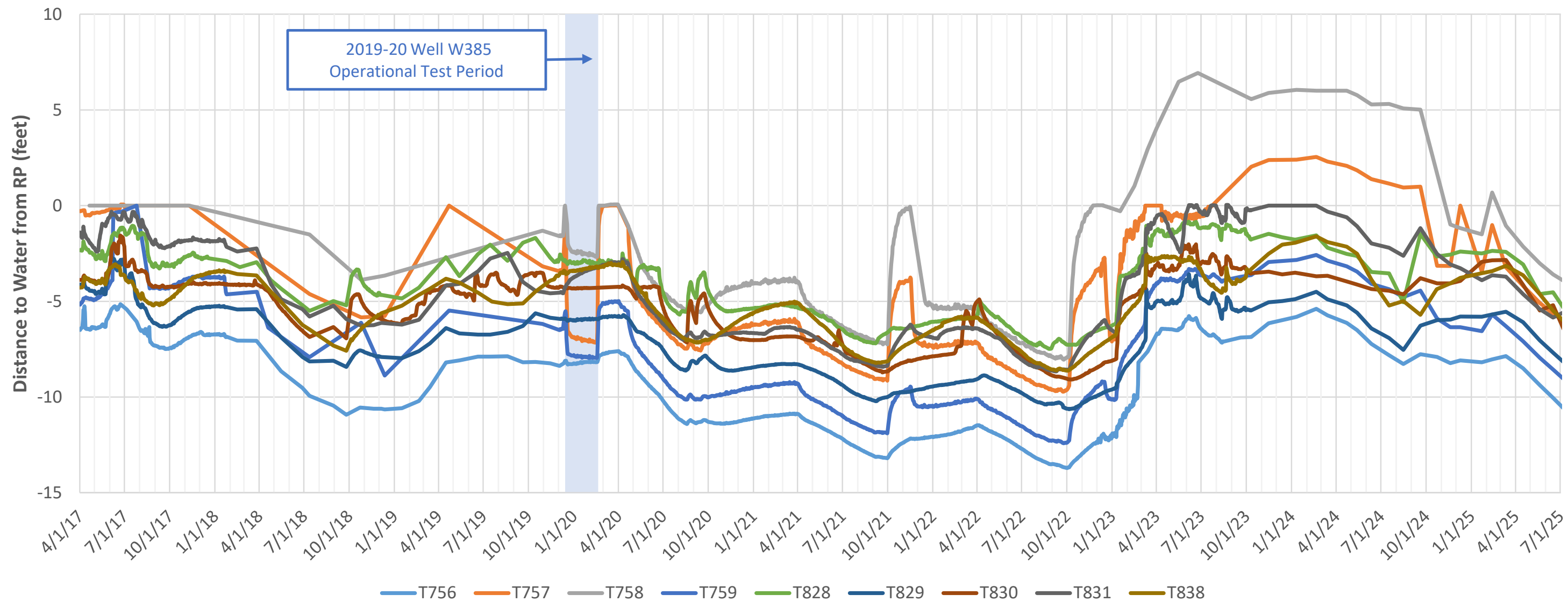


Note that T978D was experiencing artesian conditions from November 2023 to September 2024 and was not measured during that period.

Test Monitoring Wells - North of Owens River

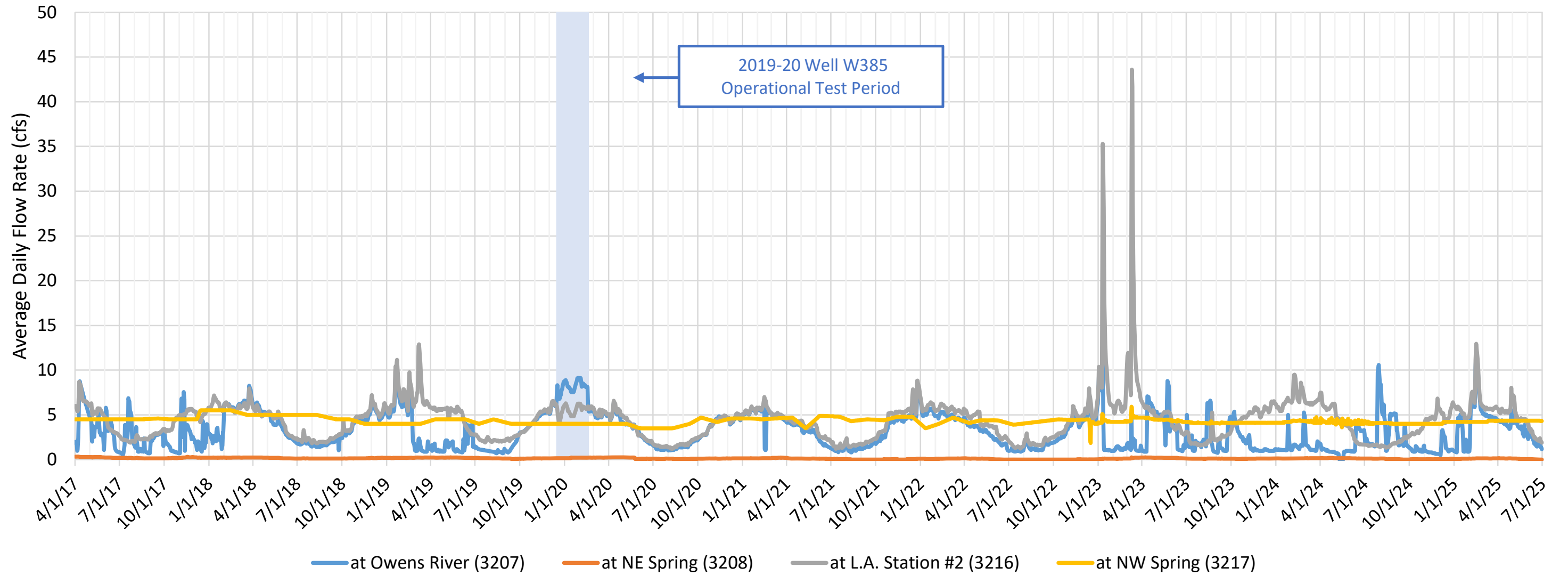


Test Monitoring Wells - South of Owens River

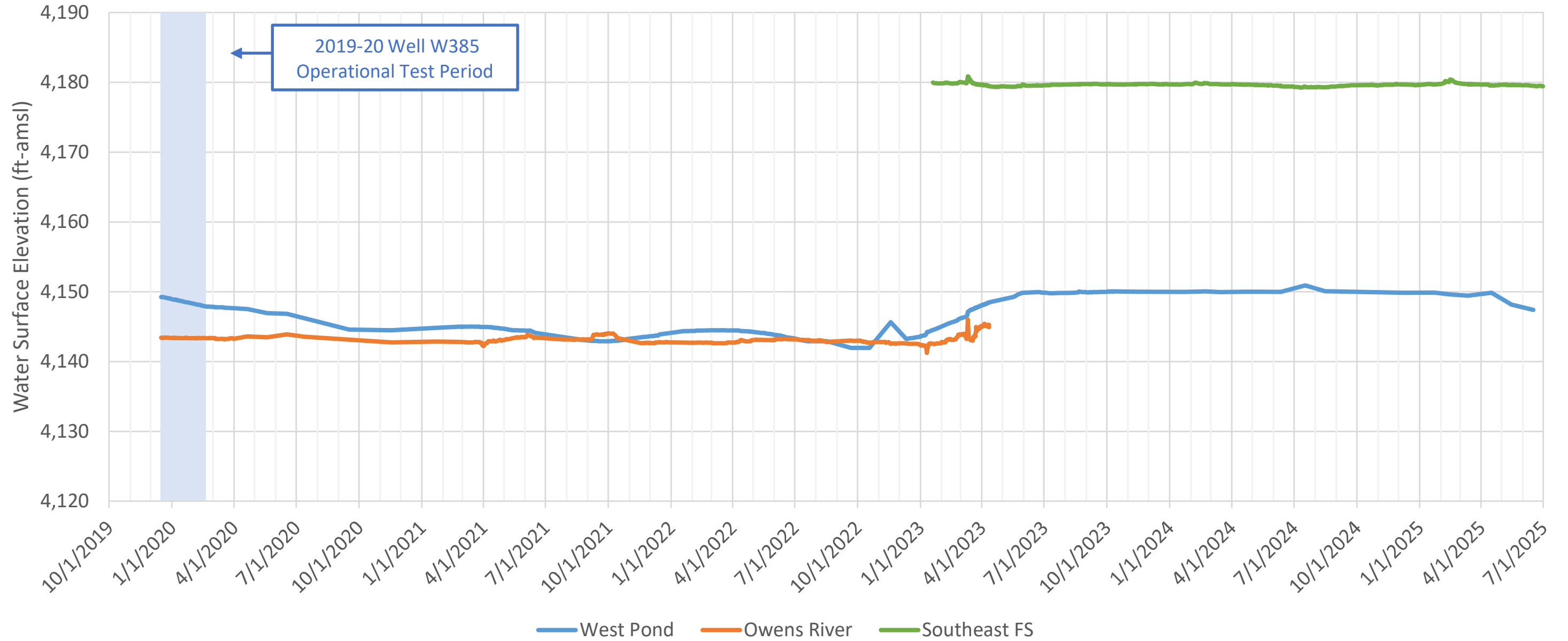


Note that W386 is not included in the above hydrograph. Nearby deep monitoring well T733 is considered a surrogate for W386.
