Thank you for your participation in and continued support of the Green Power for a Green LA (Green Power) program. By participating, you make the city of Los Angeles a cleaner and more sustainable place to live, work and play.

OVERVIEW

The Green Power program purchased 49,052 mega-watt hours (MWh) of renewable energy for our Green Power customers in 2015. A portion of these costs were offset by LADWP's avoided generation costs.

This represents enough electricity, on average, to power over 8,175 homes in Los Angeles for one year.¹ In addition, over 33,824 metric tons of carbon dioxide (CO2) emissions were eliminated, which is equivalent to the Greenhouse gas emissions from 7,121 passenger vehicles driven for one year.²

The Green Power program began in 1999 and, through year-end 2015, has provided over 1,116,614 MWhs of renewable energy to our customers. LADWP is committed to providing clean renewable energy to the city of Los Angeles.

The Green Power program met customer demand for renewable energy through 100 percent Biomass purchased from the open market.

Green Power energy to meet customer demand was obtained through energy purchases.

The cost of new Green Power is slightly higher than power generated from conventional sources such as coal and natural gas. Since the beginning of the Green Power program, the premium charged to our customers for their participation has been \$0.03/kWh as determined by the Renewable Energy Option (REO) service rider.
