Notice of Intent (NOI) to Adopt a Mitigated Negative Declaration (MND) for the

North Hollywood West Well Field Water Treatment Project

A Mitigated Negative Declaration (MND) has been prepared by the City of Los Angeles Department of Water and Power (LADWP) for the proposed North Hollywood West Well Field Water Treatment Project (Proposed Project). LADWP is the Lead Agency, pursuant to the California Environmental Quality Act (CEQA), responsible for preparation of this document.

## PROJECT DESCRIPTION

The Los Angeles Department of Water and Power (LADWP) proposes to implement a response action to address releases of 1,4-dioxane in groundwater that are migrating to the North Hollywood West (NHW) Well Field (Proposed Project, also referred to as the NHW Well Field Water Treatment Project). LADWP has removed seven wells in this well field from service due to the presence and/or threat of 1,4-dioxane contamination at the wells. Additional NHW wells are threatened by 1,4-dioxane. This response action would be achieved by installing water treatment equipment at the well field capable of removing the 1,4-dioxane to below identified cleanup levels. It would also minimize the spread of contaminant mass, limit further degradation of the groundwater basin directly downgradient of the NHW wells, remove contaminant mass from the aquifer, assist in the restoration of beneficial uses of the groundwater basin, prevent the ingestion of groundwater that exceeds cleanup levels, and restore LADWP's capability to operate its existing NHW Well Field in a flexible manner consistent with historic and planned use.

## PROJECT LOCATION

The treatment equipment would be located on property owned by LADWP that includes the affected groundwater extraction wellheads. The property is located between the Hollywood Freeway (State Route [SR]-170) and Whitsett Fields, which is part of Valley Plaza Park, in the community of North Hollywood in the City of Los Angeles. Pursuant to Section 15072 of the California Environmental Quality Act, the Project site is not on any of the lists enumerated under Section 65962.5 of the Government Code.

## **PUBLIC COMMENT PERIOD**
