NOTICE OF AVAILABILITY / NOTICE OF INTENT TO ADOPT AN INITIAL STUDY / NEGATIVE DECLARATION FOR THE PROPOSED REPLACEMENT OF WELL W390 IN THE LONE PINE WELLFIELD

Purpose

The City of Los Angeles Department of Water and Power (LADWP) proposes to replace groundwater well W390 in the Lone Pine Wellfield in Inyo County, California. As the Lead Agency under the California Environmental Quality Act (CEQA), LADWP has prepared an Initial Study/Negative Declaration (IS/ND) that evaluates potential environmental effects of the proposed project. Based on the Initial Study, LADWP concludes that the proposed project will not result in any significant adverse impacts on the environment and is hereby informing all


Agencies, Organizations, and the Public of its intent to adopt a Negative Declaration.

Project Location

The proposed replacement for Well W390 is to be installed approximately 1584 feet north of the original well's location, in an open field east of Lone Pine. Specifically, the project area is located between East Locust Street to the north and East Inyo Street to the south (see area and vicinity map, right). The main landmarks for Lone Pine Wellfield are the Alabama Hills to the west, the Los Angeles Aqueduct running along the eastern slope of the Alabama Hills, the Owens River east of the wellfield, and Lone Pine Creek and Tuttle Creek running through the wellfield.

Project Description

Well W390 is one of the exempt wells used to supply water to the Van Norman Field. It was drilled in 1987, supplying all the water pumped from it

into the Van Norman field as part of the Enhancement and Mitigation projects agreed upon by Inyo County and LADWP in a 1991 Groundwater Management Plan (the Agreement). It has since been operating, but in recent years, the well has been producing excessive amounts of sand, causing a decrease in output and pump failure. It is LADWP's goal to replace the well and to restore groundwater pumping capacity to maintain the objectives of that 1991 Agreement.

Public Review Period:

The IS/MND is available for public review for a period of 30 days beginning August 8, 2011, and concluding September 7, 2011.
