

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Owens Lake Solar Demonstration Project

The Los Angeles Department of Water and Power (LADWP) prepared an Initial Study for the Owens Lake Solar Demonstration Project. Based on the information contained in the Initial Study, LADWP intends to adopt a Mitigated Negative Declaration for the project under the California Environmental Quality Act (CEQA). LADWP is the CEQA Lead Agency for the project.

Project Location: The project site is a 5.3-acre parcel located within the 2.03-square-mile Phase 8 dust mitigation area located in the northwest section of the 110-square-mile dry Owens Lake, in Inyo County, California. The Solar Demonstration site is located on the Lone Pine 7.5 minute U.S. Geological Survey (USGS) quadrangle and the latitude/longitude of the approximate center of the area is 36.53611°N/-117.993051°W (North American Datum 1983 UTM Zone 11N).

Project Description: The Solar Demonstration Project would generate approximately 500 kW of electricity through the use of ground-mounted photovoltaic (PV) solar arrays. Solar PV panels would be installed in rows on an aluminum framework that would be attached to one of three types of foundations, two with concrete block ballasts and one with pile driven piers. The project would assist LADWP in meeting its renewable energy portfolio standards as well as provide data on the feasibility of additional solar facilities on Owens Lake.

Environmental Effects: The Initial Study describes potentially significant impacts of the proposed project on biological and cultural resources. Mitigation measures have been defined to reduce impacts to less than significant levels. Other effects found to be beneficial and less than significant are also described in the Initial Study.

Per Section 15087 (c)(6) of the CEQA Guidelines, the proposed project is not on any of the lists enumerated under Section 65962.5 of the California Government Code.
